Information Privacy Act Delegation (No. 2) 2025

1 Citation

This instrument of delegation is to be cited as the *Information Privacy Act Delegation* (No. 2) 2025.

2 Definitions

For the purposes of this instrument of delegation—

Privacy principles means the obligations in Chapter 2 of the Act

QCAT means the Queensland Civil and Administrative Tribunal.

3 Commencement

This instrument of delegation commences on the day it is executed.

4 Powers Delegated

The powers or functions, including any incidental powers, of the Information Commissioner referred to in Column 1 of the Schedule are delegated to the holder of the position and the person acting in the position from time to time, referred to in Column 2 opposite the power.
