Information Privacy Act Delegation (No. 6) 2025

1 Citation

This instrument of delegation is to be cited as the *Information Privacy Act Delegation* (No. 6) 2025.

2 Definitions

For the purposes of this instrument of delegation—

Act means the Information Privacy Act 2009 (Qld)

Office means the Office of the Information Commissioner

QCAT means the Queensland Civil and Administrative Tribunal

QPP means the Queensland privacy principles obligations in Chapter 2 of the Act.

3 Commencement

This instrument of delegation commences on the day it is executed.

4 Powers Delegated

The powers or functions, including any incidental powers, of the Information Commissioner referred to in Column 1 of the Schedule are delegated to the holder of the position and the person acting in the position from time to time, referred to in Column 2 opposite the power. The Information Privacy Act Delegation (No 4) 2025 continues in force where Chapter 8, Part 3 of the Act is engaged.
