## Right to Information Act Delegation (No. 2) 2024

### 1 Citation

This delegation may be cited as *Right to Information Act Delegation (No. 2) 2024*.

### 2 Definitions

For the purposes of this delegation—

**Act** means the *Right to Information Act 2009*

**Office** means the Office of the Information Commissioner

### 3 Commencement

This delegation shall commence on the day it is executed.

### 4 Power to Delegate

This delegation is made under section 145 of the Act.

### 5 Powers Delegated

The powers or functions, including any incidental powers, of the Information Commissioner referred to in Column 1 of the Schedule are delegated to the holder of the position and the person acting in the position from time to time, referred to in Column 2 opposite the power.


