## Right to Information Act Delegation (No. 5) 2025

#### 1 Citation

This instrument of delegation is to be cited as the *Right to Information Act Delegation* (No. 5) 2025.

### 2 Definitions

For the purposes of this instrument of delegation—

Act means the Right to Information Act 2009 (Qld)

Office means the Office of the Information Commissioner

#### 3 Commencement

This instrument of delegation commences on the day it is executed.

## 4 Powers Delegated

The powers or functions, including any incidental powers, of the Information Commissioner referred to in Column 1 of the Schedule are delegated to the holder of the position and the person acting in the position from time to time, referred to in Column 2 opposite the power. The Right to Information Act Delegation (No 3) 2025 continues in force where Chapter 7, Part 9 of the Act is engaged.
