The Office of the Information Commissioner (OIC) is Queensland's independent statutory body with statutory functions under the *Right to Information Act 2009* (Qld) (RTI Act) and the *Information Privacy Act 2009* (Qld) (IP Act) to promote access to government-held information, and to protect people's personal information held by the public sector.

OIC provides information, assistance and advice to support Queensland public sector agencies to comply with the law, reviews agency decisions regarding access and amendment applications, monitors and reports to the Queensland Parliament on agency performance and mediates privacy complaints.

The 10th anniversary campaign

In 2009 the RTI Act and IP Act started a fundamental shift in how government handles, uses and discloses information. Queensland moved to a push model where information is released proactively, unless there is a good reason not to, while protecting and respecting personal information.

The 10th anniversary will mark a significant milestone in the legislation's operation and presents an opportunity to showcase Queensland's journey towards a more open, transparent and accountable government.

Promotional activities will run from Privacy Awareness Week in May 2019 until Right to Information Day in September 2019. Throughout this period we will be undertaking a number of campaigns such as 'Tell us your story' and 'Did you know'. We will also be hosting an event in August which will include the Solomon Lecture and panel discussion.

We will be encouraging all supporters to get involved and show support for a more open, transparent and accountable government that protects and respects personal information.
